**NOTICE OF REQUIREMENTS**

1. The University's General Terms and Conditions and Instructions to Bidders, viewable at <http://procurement.nku.edu/policies/terms-and-conditions.html>, apply to this Request for Proposal.
2. Contracts resulting from this RFP must be governed by and in accordance with the laws of the Commonwealth of Kentucky.
3. Any agreement or collusion among Offerors or prospective Offerors, which restrains, tends to restrain, or is reasonably calculated to restrain competition by agreement to bid at a fixed price or to refrain from offering, or otherwise, is prohibited.
4. Any person who violates any provisions of KRS 45A.325 shall be guilty of a felony and shall be punished by a fine of not less than five thousand dollars nor more than ten thousand dollars, or be imprisoned not less than one year nor more than five years, or both such fine and imprisonment. Any firm, corporation, or association who violates any of the provisions of KRS 45A.325 shall, upon conviction, may be fined not less than ten thousand dollars or more than twenty thousand dollars.

The purpose of this solicitation is to establish a price contract so that NKU may order stone as needed for environmental restoration projects. The term of this contract will be (1) one year. NKU reserves the right to award to multiple bidders based on price, product availability, delivery schedule and other factors.

**SCOPE:**

Please use the form of proposal below to indicate pricing for derrick stone (boulders) 2' X 3' X 3', class 3 channel liner, class 2 channel liner, 57 gravel, cyclopean rip rap, & crushed stone base. Please note that bidders may price any or all types of stone.

**METHOD OF AWARD:**

It is the University's intention to make the award to the qualified, responsive and responsible bidder(s) whose bid offers the best value to the University.

**SPECIAL CONDITIONS:**

1. Supplier to deliver stone to project sites in Boone, Kenton, Campbell, and Gallatin Counties.
2. All stone to be dumped, not individually removed at project sites.
3. Derrick stone (boulder) size understood to be variable but approximate.
4. Stone to be free from seams and cracks and of sufficient hardness for stream stabilization purposes.

**PRICE ADJUSTMENTS:**

All prices quoted in response to this Invitation for Bid shall be fixed and firm through the end of the contract term.

**INVOICING AND PAYMENT:**

The Contractor shall be paid upon submission of a proper invoice, to the billing address shown on the Purchase Order.
