METHOD OF AWARD:

It is the University's intention to make the award to the qualified, responsive and responsible bidder(s) whose bid offers the best value to the University.

SPECIAL CONDITIONS:

- 1. Supplier to deliver stone to project sites in Boone, Kenton, Campbell, and Gallatin Counties.
- 2. All stone to be dumped, not individually removed at project sites.
- 3. Derrick stone (boulder) size understood to be variable but approximate.
- 4. Stone to be free from seams and cracks and of sufficient hardness for stream stabilization purposes.
